FCC to Require Two Factor Authentication for CORES Users

(ARRL 03/22/24) The Federal Communications Commission (FCC) has announced an upcoming change to the Commission Registration System (CORES) that licensees use to pay any application or regulatory fees, manage or reset a password on an existing FRN, or request a new FRN. Beginning March 29, 2024, multifactor authentication will be implemented. Users will be prompted to request a six-digit secondary verification code, which will be sent to the email address(es) associated with each username. The user will then need to enter the code into CORES before they can continue.

In a public notice, the FCC said this change will make the system more secure. "This additional layer of security will further safeguard against unauthorized access, thereby enhancing the overall integrity of information contained within the CORES system and improving the security of user data," it read.

The FCC recommends that users confirm they have access to their username account email and to add a secondary email address, if need be.

Solar Eclipse April 8

(ARRL 03/08/24) A total solar eclipse that will be seen across North America will occur on Monday, April 8th. It will be the last of its kind in the US for the next 20 years.

Hams across North America are asked to participate in a study about how the ionosphere functions by getting on the air to help scientists in a series of ionospheric experiments.

Ham Radio Science Citizen Investigation (HamSCI) has presentations for hams interested in participating on Wednesday, March 27 at 7:00 PM (Central), and that same day at 9:00 PM (Central). Both 30-minute presentations will

held on Zoom and they will feature HamSCI's Festivals of Eclipse Ionospheric Science (FoEIS). The presenters will take your questions during the presentations.

The program will start by covering HamSCI's basis and purpose, and quickly move into why they are conducting experiments, how hams and shortwave listeners (SWLS) can participate, and what they hope to learn from the event. Along the way, they will discuss why the science behind the event is important to users of the high-frequency radio spectrum - including amateur radio operators!

The February Meeting was held at Mom's Café on Saturday, February 24, 2024. The meeting was called to order by President Roger Behrns at 8:30 am.


